# Chiefs Report May 2022

The month of May was very busy with call volumes 33% higher than last year at 59 calls for service (49 calls in 2021, and an average of 40 in May over the last three years). We did not receive or give mutual aid this month. We had two calls where mutual aid was requested but we were able to respond shortly after and cancel them prior to their arrival on scene. Our priority response time was excellent at 4:51 and we had five BLS transports.

Both the Browns Point and Buckley academies are finishing their Hazardous Materials training and have begun prepping for IFSAC testing in June. Kaylee Garrett from Buckley fire came out for three separate drill nights and taught new EMT protocols to our members. All new equipment and medications have been added to the rigs and we are ready to implement them. With academies coming to an end, we have scheduled driver training, Pump Operations and Firefighter 2 which will begin in July. Captain Thor completed his Hazardous Materials IFSAC certification and BC Cramer is now an OTEP instructor.

Operations continues to focus on the staffing schedule, assisting with training, equipment repairs and maintenance. Vehicle work completed has included the ATV transmission issue and the brush truck was placed into service for the summer. Spring clean up is in full swing with garden beds being weeded and mulched, touch-up paint on the station, and general grounds maintenance. The new windows in the back office have been installed providing a tremendous moral boost for the staff.

The Administrative Division continues to work on increasing funding through grants and other programs. Unfortunately, we did not receive the DNR grant that would have allowed us the purchase of a new Brush truck. We did, however, submit for another round of Covid funding and should see a little over \$15,000 which includes covering the overtime we have had to pay due to illnesses and staffing shortages. We also continue to see GEMT money from transports and expect to see a settlement of just under \$50,000 for SFY2021 in the coming month.

The focus of June will be assisting the recruits in their IFSAC testing, recruitment for the next academy and preparations for the upcoming classes Riverside is hosting. We are also continuing work on the station modifications for the new fire engine purchase.




